## WHAT DOES Second Round, LP DO WITH YOUR PERSONAL INFORMATION?

<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
<b>What?</b>	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>■ Social Security number and Contact Information</li> <li>■ Account Balances and Payment History</li> <li>■ Assets and Employment History</li> </ul> <p>When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.</p>
<b>How?</b>	All financial companies need to share consumer's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their consumer's personal information; the reasons Second Round, LP chooses to share; and whether you can limit this sharing.

## What we do

How does **Second Round, LP** protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does **Second Round, LP** collect my personal information?

We collect your personal information, for example, when you

- provide account information or provide income
- pay Second Round, LP or provide employment information
- provide contact information

We collect updated address information from our affiliates

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

## Definitions

**Affiliates**

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- Second Round Sub, LLC
- Third Round Limited Partnership
- Crown Asset Management, LLC

**Nonaffiliates**

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- 3rd Party Vendors

**Joint marketing**

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
